

**Millersburg Area School District and Upper Dauphin Area School District Sports Cooperative
Joint Statement on Extracurricular Activities
October 8, 2020**

On October 6, 2020, Governor Tom Wolf and Secretary of Health Dr. Rachel Levine signed an amendment to the “Directing Mitigation Measures” Order, dated July 15, 2020. The Order, as amended, will take effect on Friday, October 9, 2020 at 12:01 a.m. As a result, the Millersburg Area and Upper Dauphin Area School Districts are implementing a modified version of Spectator Level B as defined in the Joint Statement issued on September 16, 2020. The administrative teams of both districts will continually evaluate the spectator levels and make decisions for future events based on criteria identified in the Addendum to the Extracurricular Health and Safety Plan.

Table 1 provides details about the modified Spectator Level B.
